1. Introduction

a. Background to JTAX Office Solutions

JTAX management has long recognized that foreign clients require one-stop solutions in Japan and that those needs include solutions for Japan registered address and Japan virtual office requirements. As a result, the JTAX team has been assisting clients with registered address and office solutions since 1997. JTAX has since become a leading provider of registered address and virtual office solutions in Japan. In 2016, JTAX purchased an office in central Tokyo to further enhance our ability to assist clients with reliable long term office solutions.

b. Office & Address Requirements for Foreign Companies in Japan

At a minimum, establishing a company in Japan requires a legal registered address in Japan. Beyond satisfying this minimum legal requirement, running the Japan business may require having either a virtual office or a serviced office.

JTAX provides registered address and virtual office solutions via an office that we own in downtown Tokyo. Ownership of our premises helps ensure long term stability.

2. JTAX Registered Address Services

JTAX Japan Registered Address Service is designed to meet the minimum legal address requirements for our client's Japan operations.

All companies in Japan (i.e., Kabushiki Kaisha ("KK"), Godo Kaisha ("GK"), Japan Branches of Foreign Companies, and Japan Representative Offices) are required to have a legal registered address in Japan. That legal registered address in Japan appears on the company's official certificate of registered particulars ("tokibo tohon") and is therefore a matter of public record.

Importantly, JTAX registered address service is provided via an office that we own in central Tokyo. The helps to ensure long term stability.

Why is Your Company's Japan Legal Registered Address Important?

The Japan legal registered address is important for a number of reasons including:

- A Japan legal registered address is a key requirement for registering a company in Japan – i.e., a Kabushiki Kaisha ("KK"), Godo Kaisha ("GK"), or a Japan Branch of a Foreign Company.
- For Kabushiki Kaisha ("KK"), Godo Kaisha ("GK"), and Japan Branches of Foreign Companies, the legal registered address will appear on the certificate of registered particulars ("tokibo tohon"). This is a publicly available document.
 - In order to project a strong commercial image, it is recommended that the legal registered address be located in a premium area of Tokyo. JTAX address is within Tokyo's highly sought after real estate "Golden Circle".
- It is the address to which most official correspondence will be sent by default.
 - For example, tax related documents, plus communications from other Japanese government agencies, will be sent by default to the Japan legal registered address.
- It is the address to which legal documents (for example related to the commencement of legal proceedings) will be sent.

The Importance of a Stable Registered Address

It is important that your company have a stable registered address in Japan. Changing the registered address (for example each time the main business address changes) involves significant time (more than one month), expense (typically at least USD2,000-). In addition, notifications need to be made to banks, the Japan tax office, etc.

JTAX registered address service is provided via an office that we own in central Tokyo. This provides greater stability than when a registered address is provided via leased premises.

What is Included in JTAX Registered Address Service?

JTAX Registered Address Service is designed to satisfy the minimum legal address requirements for a business entity in Japan. It is not designed to be used for commercial purposes (i.e., it should not be used on business cards, letterhead, websites, advertisements, or other marketing materials.) If more than a legal registered address is required, you may wish to consider JTAX Japan Virtual Office Service.

Features of Our Japan Registered Address Service

- You may use the JTAX address for the purpose of a legal registered address for your Japan business entity including:
 - Kabushiki Kaisha ("KK")
 - Godo Kaisha ("GK")
 - Japan Branch of a Foreign Company
 - Japan Representative Office
- You may utilize our address from the time of incorporation or you can change an existing registered address to our premises.
 - Our team can assist with the procedures if the address is being changed from an existing address.
 - We can also handle the incorporation if you'd like to establish a new company.
- Our Registered Address Service is provided from premises that we own in central Tokyo.
 - This ensures long term stability which is not available when the registered address is provided from rented premises.

JTAX Registered Address is Cost Effective

A stable registered address avoids the cost (often several thousand USD) and time (often a month or more) involved in shifting the registered address each time the business address moves. A stable registered office address also avoids the time-consuming task of notifying banks and the tax office each time a move occurs.

Mail received at the Registered Address will be forwarded to a single recipient on a monthly basis. (Additional mailings may be available for an additional fee.)

3. JTAX Virtual Office Service

What is a Virtual Office?

A virtual office is similar to a regular office in that it provides many basic office functions -- phone answering, voice mail, mail receiving / forwarding, etc. However, in contrast to a regular office, there is no physical office space associated with a virtual office.

Is a Virtual Office Suitable for Our Organization in Japan?

Virtual offices project a professional image while keeping costs low. As a result, virtual offices work well in a range of situations including:

- For start-ups that are seeking a professional image for a reasonable price.
- For organizations practicing "lean business" which involves highly connected employees working from home or directly engaging clients.
- For foreign companies that have some business in Japan but not sufficient to justify a more substantial presence.
